ABSTRACT

The book entitled “*Updates on Tropical Mushrooms*”, will include chapters on subjects related to the biology, diversity, cultivation, nutritional and medicinal aspects, biotechnological applications, etc. of tropical mushrooms. We expect to complete a book that condenses knowledge and highlights the progress observed on the science and technology of this particular kind of mushrooms. For contributing to this book, several well known specialists have been invited. The book will include also the articles that after being presented at the *International Symposium of Tropical Mushrooms*, in Tapachula, Chiapas, (1-2 December 2016), be selected by the editors and pass through a peer reviewing process. The book will be published in English.

INTRODUCTION

The manuscript should be prepared in Microsoft Word or other readily translatable format on letter size paper (21.6 cm x 27.9 cm) with 3 cm left and top margins and 2 cm right and bottom margins. Use single-spaced typing in 11-point or 10-point "Times New Roman" font as indicated throughout the manuscript (“References” and the “Abstract”, sections should be in 10-point type). Italicize Latin names of organisms (genus, species, and subspecies). The text should have justified left and right margins, and use block style for separating paragraphs (i.e., do not indent the first line, just leave a single space between paragraphs). Page numbers should appear in the lower right hand margin. It is desirable to have manuscripts averaging 15 pages including figures, photographs, and tables.

After the title, leave one blank line followed by the authors and their affiliations. After the authors and affiliations, leave two blank lines followed by the abstract text. The abstract should have left and right justified margins and no paragraph breaks. The abstract, excluding the title and names and affiliations of the authors, is limited to a maximum of 200 words summarizing the chapter information. Submission deadline for the abstract is September 30, 2016. The full document may be sent to the editors on December 1, 2016, to the following addresses: esanchez@ecosur.mx or gerardo.mata@inecol.mx

PRIMARY HEADINGS ARE CENTERED AND IN BOLD CAPITAL TYPE LIKE THIS

Secondary headings are in bold, lower case type, and justified left like this

Leave a single blank space after both primary and secondary headings. Primary headings are centered, while secondary ones are justified left. If a heading falls at the bottom of a page, it should be carried to the next page.

Tertiary headings

This kind of heading is in regular (not bold face), lower case type, and justified left like this. After a tertiary heading, start the text immediately on the next line without leaving a blank space.

TITLE

The title should not exceed 45 characters. The title is centered on the page and is in bold capital letters. The full names of the authors in regular, lower case type appears centered on the next line following the title. The complete mailing addresses, affiliations, and e-mail addresses (if available) of the authors in regular, lower case type and centered begins on the next line following the authors' names. Leave two spaces between the authors' addresses, etc. and the "Abstract" section. The organization of the text in different sections falls into the responsibility of each author, as it does the contents. The manuscript may contain the following sections and sequence: Abstract, Keywords, Introduction, (and other headings of the authors choice) Acknowledgments, and References.

ABSTRACT

The abstract is limited to a maximum of 200 words, and should summarize the objectives and main message of the chapter. Refrain from using abbreviations and references in this section.

INTRODUCTION

The introduction should provide sufficient background information to allow the reader, who may be unfamiliar with the topic, to understand and evaluate the importance of the subject described in the chapter.

OTHER HEADINGS OF THE AUTHOR'S CHOICE

Limit this section to a succinct, but accurate, description of the subject. Tables should be self explanatory with concise headings. Each table should be cited in the text, and numbered consecutively. Footnotes lending clarity to the data contained within the table are encouraged. Both figures and photographs are considered figures and, therefore, should be numbered consecutively and in the order of their appearance within the text. Figures should be inserted in the text closely following their initial reference.

Whenever possible, use abbreviations throughout the text according to the SI system as follows:

ACKNOWLEDGMENTS

Briefly recognize those individuals who contributed in a meaningful way to the development of the chapter and indicate all sources of financial support.

REFERENCES

Full details of all publications cited in the text should appear in a list of references. Particular care must be taken to insure that all references in the list are cited in the text, and that all references cited in the text appear in the list. Re-check the spelling of author's names for accuracy, and the consistency in formatting the references.

References should be cited in the text using the Harvard System (author's name and year of publication). Personal communications should not be included in the reference list, but cited in the text within parentheses, as for example (Smith IM 2002, pers comm). The following are examples of the Harvard System for listing references:
